## **CONDITIONS OF HIRE**

- 1. The applicant agrees to set the trap only within their property boundaries and not on public property or common land in accordance with section 23 of the Public Spaces (Unattended Property) Act 2021;
- 2. The trap will not be used to capture protected wildlife and if a protected animal is unintentionally captured the applicant will notify the relevant authority;
- 3. The trap is to be used for the sole purpose of the humane capture of feral/stray cats which are entering onto the applicant's property
- 4. The applicant must advise immediate neighbours that a trap is being placed on the applicant's property and immediately release any trapped domestic cat or a cat known to be owned by a person, other than a feral cat, at the place where the trap was set;
- 5. The applicant agrees to report any trapping of a cat to Port Stephens Council Rangers during 8am to 4pm in accordance with section 62 of the Companion Animals Act 1998 within 24 hours of detection; alternatively to convey any trapped cat immediately to Port Stephens Council's Animal Refuge at 267B Woodberry Road Millers Forest NSW 2324;
- 6. The applicant agrees to use uncontaminated food as bait to trap the cat and to provide for any trapped animal's wellbeing whilst in the trap including food, water, shelter and veterinary expenses and to protect such animal from harm from any other person or animal;
- 7. The applicant acknowledges they will be liable to prosecution under the Prevention of Cruelty to Animals Act 1979 should they fail to ensure the welfare of the trapped animal;
- 8. The applicant will contact Port Stephens Council Rangers to collect and impound any trapped domestic dog; alternatively to convey any trapped feral dog immediately to Port Stephens Council's Animal Refuge at 267B Woodberry Road Millers Forest NSW 2324;
- 9. The applicant will obey all reasonable directions from Council Rangers concerning use of the trap and any trapped animal;



- 10. The applicant will return the trap to Council after 7 days or, alternatively, request approval for an extension of time, for which an additional hire cost may be payable;
- 11. If the trap is returned damaged, is lost or misplaced, a fee may be deducted from the deposit or the entire deposit may be forfeited;
- 12. If the trap is not returned by the agreed date, a weekly fee covering the additional time the trap was in the applicant's possession will be deducted from the deposit or the entire deposit may be forfeited;
- 13. The applicant is aware that Council's operating hours are 8.30am to 5.00pm, Monday to Friday.
- 14. The applicant accepts full responsibility for any action taken by them during the loan of the trap and hereby agrees to comply with the above conditions.
