# Marsh Road, Bobs Farm - Request for an update on road safety concerns

### Background:

Cr Anderson has requested an update on the previous resident request below: "The road is in extremely poor condition in more than one area and has got worse during the two lane highway upgrade.

Many people have used Marsh Road as an alternative route, rather than using the Nelson Bay 60k stretch being upgraded, its seen as the fastest route. The two lane highway continues but Marsh Road over many year's has been the Road to take in the event of known accidents, it deserves to be safe to drive.

I understand that funding is difficult for road repairs and maintenance but the extremely poor condition of Marsh Road may warrant the speed being slowed to 60ks per hour. I'm pretty sure this wouldn't be a favourable option but safety needs to be considered. Many people drive down the centre of the road to avoid potholes & missing road.

Two deaths have accord on this road that I know about in past years, long term it maybe subject to blackspot funding but until than maybe let's slow the speed."

# **Comment:**

TfNSW advises that a Speed Zone Review was undertaken in 2019 for Marsh Road, Bobs Farm, to review the existing 80 km/h speed limit. The length of road reviewed was from the existing 60/80 change, 660m west of Nelson Bay Road (Bobs Farm end) southerly by 1300m. This review was subsequently withdrawn as investigations deemed there would be no change to the speed limits on Marsh Road.

This result is still relevant to Marsh Road and no additional speed zone review is deemed warranted at this time.


#### **Discussion:**

The TfNSW representative shared that speed zoning looks at the overall formation of a road according to established criteria and remains independent of road condition (which may vary). TfNSW reiterated that speed zone reviews are not Local Traffic Committee items and further discussions should take place outside the meeting. Council officers will look at the possibility of temporary speed reductions associated with minor works on Marsh Road.

Tarean Road, Karuah - Request for a bus zone

Requested by: Busways 578215

Background:

Busways have requested for installation of signage to deter vehicles being parked at the bus stop adjacent to the Karuah Motor Inn, on Tarean Road, Karuah.

## Legislation, Standards, Guidelines and Delegation:

NSW Road Rules – Rule 183 – Stopping in a bus zone

TfNSW signs database – R5-20

Traffic control devices installed under Part 5.3 Div. 2 Road Transport Act 2013

#### **Discussion:**

The TfNSW representative questioned whether the proposed signage left space between the post and the driveway. The proposed location of the post is confirmed to be on the edge of a second (hidden) driveway, therefore the sketch is correctly placed. The TfNSW representative also made note of the Bus Stop pole being located at a distance from the shelter. This should be located at the shelter for buses to stop here. Council will request CDC to relocate their pole.





## Norburn Avenue, Nelson Bay - Request for 'No Stopping' restrictions

Requested by: Karingal Pre-school

**File:** 376859

Background:

A bus recently clipped a parked car at the corner of Gowrie and Norburn Avenue, Nelson bay. CCTV footage shows the vehicle had been parked too close to the intersection of Norburn and Gowrie and the bus could not safety manouvre around the corner. The pre-school has requested assistance in making it clear to parents where parking is allowed.
